

Decision of the Executive Board of Rail Freight Corridor North Sea - Baltic (RFC8)

approving the Implementation Plan of Rall Freight Corridor North Sea - Baltic

Having regard to:

- Regulation (EU) No 913/2010 of the European Parliament and of the Council of 22 September 2010 concerning a European rail network for competitive freight and in particular Article 9(1) and Art 9(2);
- The Annex to the Regulation (EU) No 913/2010, as amended by Regulation (EU) No 1316/2013 of the European Parliament and of the Council of 11 December 2013 establishing the Connecting Europe Facility;

The Executive Board of Rail Freight Corridor North Sea - Baltic (RFC8):

- 1. Approves the Implementation Plan of the Rail Freight Corridor North Sea Baltic as drew up by the Management Board, annexed to this Decision;
- 2. Notes that, following the approval of the Implementation Plan, the Framework for Capacity Allocation (FCA) applies to the categories and specified lines of Rall Freight Corridor North Sea Baltic, as defined in this Plan in order to have the same allocation procedures along the corridor;
- 3. Welcomes the indicative investment plan of Rall Freight Corridor North Sea Baltic as part of the implementation Plan but without prejudice to each Member State remaining responsible for its own infrastructure decisions and its financing;
- 4. Gives the mandate to the Management Board to publish the Implementation Plan and to update, in conformity with the Implementation Plan, the Corridor Information Document.
